COUNT 1

On or about January 29, 2020, in the above named judicial district, the crime of USING MINOR FOR SEX ACTS, in violation of PENAL CODE SECTION 311.4(c), a felony, was committed by David Arthur Riden, who did unlawfully and in possession of facts on the basis of which the defendant(s) should reasonably have known that Jane Doe was a minor under 18 years, promote, employ, use persuade, induce and coerce the minor to engage in and assist others to

engage in: posing and modeling alone and with others for purposes of preparing a film, photograph, negative and slide.

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime."

COUNT 3

On or about February 4, 2020, in the above named judicial district, the crime of USING MINOR FOR SEX ACTS, in violation of PENAL CODE SECTION 311.4(c), a felony, was committed by David Arthur Riden, who did unlawfully and in possession of facts on the basis of which the defendant(s) should reasonably have known that Jane Doe was a minor under 18 years, promote, employ, use persuade, induce and coerce the minor to engage in and assist others to engage in: posing and modeling alone and with others for purposes of preparing a film, photograph, negative and slide.
