INTRODUCTION

2 1. This action alleges violations of the Ralph M. Brown Act ("Brown Act"), Government Code §54950 et seq., by the San Bernardino County Board of Supervisors ("Board") in the process of appointing Dawn Rowe to the position of Third District Supervisor.

5 2. On December 10, 2018, in violation of the Brown Act, the Board conducted a 6 secret ballot, via seriatim electronic mail communications, to determine which of the 48 7 candidates for the then-vacant Third District Supervisor position would be interviewed for the 8 position. Candidates who were not selected via this secret and seriatim ballot were excluded 9 from further consideration. The Board then interviewed only those 13 candidates selected via 10 secret and seriatim ballot on December 11, 2018 and narrowed the candidates under 11 consideration to five finalists from this group.

3. Following the selection of five finalists, the Board scheduled a special meeting to 13 appoint the Third District Supervisor on December 13, 2018. After being notified that its secret 14 ballot process used to identify 13 candidates for interviews had violated the Brown Act, 15 however, the Board quickly adjourned the meeting on advice of counsel.

16 4. Prior to the December 13, 2018 meeting, Petitioners and others had notified the 17 Board that these actions had violated the Brown Act and that this violation could be cured only 18 by interviewing the candidates who had been unlawfully excluded from consideration through a 19 secret ballot and seriatim communications. Instead of interviewing (or offering to interview) the 20 unlawfully excluded candidates, however, on December 18, 2018, the Board instead purported to 21 "rescind" its prior selection of 13 candidates for interviews and subsequent narrowing to five 22 finalists, voted to re-interview five of the original finalists plus one additional candidate, and 23 then unanimously voted to appoint Dawn Rowe to the vacant Third District Supervisor position. 24 Ms. Rowe and two other candidates had received the highest number of votes in the December 25 10, 2018 secret and seriatim ballot process, and Rowe had received the most votes on December 26 11, 2018 following the interviews of the unlawfully selected 13 finalists.

1 5. The Board violated the Brown Act by privately meeting, using seriatim 2 communication and a secret ballot, to select 13 finalists to be interviewed and considered for the 3 vacant Third District Supervisor position. When alerted to this violation, the Board failed to take 4 the necessary curative action that would have removed the unfair advantage-a Board 5 interview-it had conferred on the candidates who benefitted from the secret winnowing of the 6 applicant pool to 13 finalists. Instead, by forging ahead to re-interview five of the applicants it 7 had previously interviewed, along with only one applicant who did not make that illegal first cut, 8 the Board effectively capitalized on its illegal vote by filling the vacancy from a select, illegally 9 advantaged pool.

6. As a result of the Board's actions, the public has been deprived of its right to
know which candidates each Supervisor supported for the vacant position, the candidates who
were not selected for interviews on December 11, 2018 have been denied an opportunity for fair
and public consideration for the vacant supervisor position, and the public has been denied the
opportunity to meaningfully consider and comment on all the candidates, all in violation of the
Brown Act.

PARTIES

7. Petitioner Michael Gomez Daly ("Gomez Daly") is, and at relevant times was,
Executive Director of Inland Empire United, a project of The Advocacy Fund that represents
progressive community groups in the Inland Empire, and a resident and taxpayer of the State of
California.

8. Petitioner Inland Empire United is a community-based organization, comprised of
a number of member organizations and community leaders, committed to electing progressive
candidates of color to local boards and municipalities in Riverside and San Bernardino Counties.
Inland Empire United's purpose is to address the historic and ongoing underrepresentation of
people of color among elected officials in Riverside and San Bernardino Counties and to support
candidates who will advocate on behalf of communities of color. The community leaders who
are members of Inland Empire United include taxpayers and residents of San Bernardino County

and the Third District. In addition, Inland Empire United's member organizations themselves
 have individual members who are taxpayers and residents of San Bernardino County and the
 Third District. Inland Empire United and its members are interested in ensuring that the Third
 District on the San Bernardino County Board is represented by a Supervisor who reflects the
 needs and preferences of the entire Third District, and that the process for selecting this
 Supervisor is open, transparent, and accessible to candidates of color and their supporters.

7
9. Respondent San Bernardino County Board of Supervisors ("Board") is, and at all
8 relevant times was, the governing body of the County of San Bernardino, a charter county and
9 political subdivision of the State of California, and a legislative body subject to the requirements
10 of the Ralph M. Brown Act, §54950 *et seq*.

11 10. Respondent Robert A. Lovingood ("Lovingood") is and was at all relevant times
12 the First District Supervisor and Chair of the Board. Lovingood is a member of a "legislative
13 body" within the meaning of the Ralph M. Brown Act. Gov. Code §54952.

14 11. Respondent Janice Rutherford ("Rutherford") is and was at all relevant times the
15 Second District Supervisor of the Board. Rutherford is a member of a "legislative body" within
16 the meaning of the Ralph M. Brown Act. Gov. Code §54952.

17 12. Respondent Curt Hagman ("Hagman") is and was at all relevant times the Fourth
18 District Supervisor and Vice Chair of the Board. Hagman is a member of a "legislative body"
19 within the meaning of the Ralph M. Brown Act. Gov. Code §54952.

20 13. Respondent Josie Gonzales ("Gonzales") is and was at all relevant times the Fifth
21 District Supervisor of the Board. Gonzales is a member of a "legislative body" within the
22 meaning of the Ralph M. Brown Act. Gov. Code §54952.

14. Real Party in Interest Dawn Rowe ("Rowe") was appointed as Third District
Supervisor for the Board on December 18, 2018, through a process that violated the Brown Act.
Respondents' appointment of Rowe to the Board is the subject of this lawsuit.

VERIFIED PETITION FOR WRIT OF MANDATE

JURISDICTION AND VENUE

2 15. Pursuant to California Code of Civil Procedure §§526 and 1085, and Government
3 Code §54960.1, this Court has jurisdiction to issue a writ of mandate and grant injunctive relief
4 to invalidate the Board's December 18, 2018 appointment of Rowe to fill the then-vacant
5 position of Third District Supervisor.

6 16. Venue is proper in this Court because the cause of action alleged in this Petition
7 arose in San Bernardino County.

8 17. Petitioners have complied with the requirements of Government Code §54960.1
9 by delivering to the Board and Supervisors on December 18, 2018 a letter demanding that the
10 Board cure or correct its Brown Act violation. A true and correct copy of the letter is attached
11 hereto as Exhibit A.

12 18. The Board, through its Counsel, responded to Petitioner on December 20, 2018,
13 claiming that it had taken "curative and/or corrective actions." A true and correct copy of this
14 letter is attached hereto as Exhibit B.

15 19. Petitioner has no plain, speedy, or adequate remedy in the course of ordinary law
16 unless this Court grants the requested writ of mandate to require the Board to set aside the
17 appointment of Rowe in violation of the Brown Act. In the absence of such remedy, the Board's
18 appointment will remain in effect in violation of state law.

FACTUAL ALLEGATIONS

20 20. In November 2016, James Ramos ("Ramos") was elected to a second four-year
21 term as the Third District Member of the Board of Supervisors of San Bernardino County, after
22 first being elected to the seat in 2012. In the November 6, 2018 General Election, Ramos was
23 elected to represent the 40th Assembly District of the California State Assembly.

24 21. The San Bernardino County Charter authorizes the remaining members of the
25 Board to fill any vacancy in the office of Supervisor within a 30-day period. If the Board does
26 not make a valid appointment within that period, the Charter provides that "such appointment
27

shall be made by the Governor." A true and correct copy of the relevant section of the San
 Bernardino County Charter is attached hereto as Exhibit C.

3

22. At a Special Meeting on November 13, 2018, the Board approved a process to 4 select an individual to fill the anticipated vacancy in the position of Third District Member of the 5 Board of Supervisors for the remainder of Ramos's term. Qualified electors of the Third District were invited to submit applications between November 14 and December 3, 2018. Beginning 6 7 December 11, 2018, the Board would "conduct public interviews of those applicants who are 8 qualified electors of the Third District and who have timely filed the application." A true and 9 correct copy of the Fair Statement of the November 13 meeting at which the Board voted on this 10 process is attached hereto as Exhibit D.

23. On December 3, 2018, Ramos was sworn in as Member of the Assembly, creating
a vacancy in his position as Third District Member of the San Bernardino Board of Supervisors.

13 24. In accordance with the process set forth in the Minutes of the Board's November
14 13, 2018 Regular Meeting, 52 individuals submitted applications for the vacancy. One
15 application was subsequently withdrawn. According to the published minutes of the Board's
16 December 4, 2018 Regular Meeting, the Clerk of the Board determined that 48 of the remaining
17 applicants were registered electors residing in the Third District of San Bernardino County and
18 therefore eligible for consideration. A true and correct copy of the relevant portion of the Fair
19 Statement of the December 4 Board Regular Meeting is attached hereto as Exhibit E.

20 25. At the Board's December 4, 2018 Regular Meeting, over the objection of 21 Supervisor Gonzales, the Board modified the selection process that it had adopted at the 22 November 13, 2018 Regular Meeting. Rather than schedule interviews for each of the 48 23 eligible candidates, as planned, the Board directed each Supervisor to submit, via electronic mail, 24 up to ten candidate names to the Clerk of the Board. Only those candidates who received at least 25 two votes in this secret and seriatim ballot would be invited to interview. Neither the December 26 4, 2018 Agenda nor any other published notice indicated that the Board would consider and vote 27 on a new selection process that limited interviews to those candidates selected by secret and

seriatim ballot. True and correct copies of the relevant portion of the Agenda and corresponding
 Report/Recommendation for the December 4, 2018 Board Regular Meeting are attached hereto
 as Exhibit F.

4 26. On information and belief, on or about December 10, 2018, Supervisors
5 Lovingood, Rutherford, Hagman, and Gonzales submitted to the County Clerk, via electronic
6 mail, the names of their preferred candidates.

7 27. The December 10, 2018 seriatim meeting that resulted in the narrowing of
8 candidates under consideration from 48 to 13 was not publicly noticed. No publicly noticed
9 document identifies either the total number of votes received by each candidate and no publicly
10 available document identifies the names of the candidates selected by each Supervisor.

28. On the basis of this secret and seriatim ballot, 13 candidates were designated
"nominees" and invited to be interviewed by the Board. These 13 "nominees" were given an
opportunity to speak directly to the Board and to answer questions, for approximately 20 minutes
each, at a Special Meeting of the Board held on December 11, 2018. Attached hereto as Exhibit
G is a true and correct copy of the Report/Recommendation to the Board of Supervisors for the
December 11, 2018 Special Meeting, including the list of 13 "nominees" to be interviewed at
that meeting.

18 29. The remaining 35 eligible candidates were not interviewed by the Board and were19 removed from the pool of candidates under consideration.

30. At the December 11, 2018 meeting, five candidates from the 13 nominees were
selected for further consideration: Bill Emmerson, Sean Flynn, William Jahn, Rhodes Rigsby,
and Dawn Rowe.

31. On December 12, 2018, Samuel Sukaton, Data and Special Projects Manager of
Inland Empire United, sent an electronic mail message to David Wert, Public Information
Officer of San Bernardino County requesting, *inter alia*, the lists of candidates sent by each
Supervisor to the Clerk of the Board as part of the December 10, 2018 vote. On December 13,
2018, Mr. Wert responded, stating that he was attaching "all of the materials that you requested"

28

in his possession, including a "tally sheet resulting from the process adopted by the board." A
 true and correct copy of this email exchange is attached hereto as Exhibit H. The attached tally
 sheet does not show which names any individual Supervisor submitted. A true and correct copy
 of this "tally sheet," as sent by Mr. Wert on December 13, 2018 is attached as Exhibit I.

32. A Special Meeting of the Board of Supervisors was noticed for December 13,
2018. The agenda for that meeting stated that the supervisors would conduct interviews of the
applicants qualified for appointment and would then select the Third District Member of the
Board of Supervisors.

9 33. Prior to the noticed meeting on December 13, 2018, Ruth Musser-Lopez 10 sent two demand letters to the Board of Supervisors, identifying the December 10, 2018 secret 11 ballot as a violation of the Brown Act and alleging that the candidates interviewed on December 12 11, 2018 did not include any candidates of color and were almost exclusively men. Ms. Musser-13 Lopez demanded that the Board cure or correct this violation by voiding the secret ballot and 14 "allow[ing] the equal processing of all 48 applicants with equal time to give their speech to the 15 Board" before the Board took its final vote to fill the Third District Supervisor position. True 16 and correct copies of these letters, sent by electronic mail, are attached as Exhibit J.

17 34. In response to Ms. Musser-Lopez's letters, and on advice of County Counsel, the
18 Board did not take further action on the selection of the new Supervisor at its December 13, 2018
19 Special Meeting. Instead, minutes after the meeting began, the Board quickly adjourned the
20 meeting.

35. On December 18, 2018, Petitioner Gomez Daly sent a letter to the Board and
Supervisors informing them that the December 10, 2018 ballot by which the 13 finalists were
selected violated the Brown Act because it was both a serial meeting and a secret ballot, and
demanding that the Board cure or correct this violation of the Brown Act by providing an equal
opportunity for all eligible candidates to be considered by the Board. *See* Exhibit A.

36. The Board did not interview, or invite to interview, the 35 candidates who had not
been selected through the December 10, 2018 secret ballot. Nor did the Board provide public

notice, or notice to the eligible candidates, of a new process in lieu of the unlawful December 10,
 2018 vote.

3 37. Instead, at its next regular meeting, on December 18, 2018, the Board voted to
4 "rescind the prior actions" it had taken with respect to the Third District vacancy. Following this
5 vote Supervisor Hagman suggested each Supervisor "put two or three names in the hat," at which
6 point the Board could ask "further" questions of the candidates or simply move to appoint a
7 Supervisor.

8 38. Supervisor Lovingood stated that he believed the Board's prior actions were
9 consistent with what was "stated in the policy" and the Board's "obligations." He then made a
10 motion to nominate Dawn Rowe for the position of Supervisor. The motion received two votes
11 in favor and did not move forward.

39. Having failed to appoint Dawn Rowe without any further process after the
purported "rescission" of the Board's earlier actions, Supervisor Lovingood then stated that they
would "go to the name cast, then," and directed the Clerk to distribute ballots. Supervisor
Gonzales asked that the individuals who received votes in this new process be brought forward
for questions. Supervisor Lovingood then moved to direct each Supervisor to submit three
names, and that each candidate who received at least one vote would be interviewed. The
motion was adopted.

40. Six individuals received at least one vote from the Supervisors during the
December 18, 2018 ballot. Those six individuals included the five candidates who had received
the most votes following the December 11, 2018 interviews. In addition, Christopher Carrillo,
who was not among the 13 "nominees" but on whose behalf several members of the public gave
comments at the December 18, 2018 meeting, received one vote, from Supervisor Gonzales. Mr.
Carrillo had also received one vote in the December 10, 2018 secret and seriatim ballot, but one
vote was not deemed sufficient at that time to qualify an individual for an interview.

26 41. Each of the six individuals who received at least one vote on December 18, 2018
27 was provided with an opportunity to answer questions from the Board at the December 18, 2018

28

meeting, immediately following the vote. At no point prior to the December 18, 2018 meeting
were applicants or the public given notice that interviews would be conducted. A true and
correct copy of the relevant portion of the Agenda for the December 18, 2018 Regular Meeting is
attached as Exhibit K. A true and correct copy of the Report/Recommendation associated with
the relevant Agenda item, which included the names of the 13 candidates who had been selected
for interviews via the December 10, 2018 unlawful secret and seriatim vote, is attached as
Exhibit L.

8 42. Five candidates, who were among the 13 selected by secret ballot on or about
9 December 10, 2018, were given the opportunity to interview on both December 11, 2018—at
10 which time they were selected as finalists—and again on December 18, 2018 after the purported
11 "rescission" of the Board's earlier actions. Those candidates were Bill Emmerson, Sean Flynn,
12 William Jahn, Rhodes Rigsby, and Dawn Rowe.

43. Other than Christopher Carrillo, none of the 35 eligible candidates who were
excluded from consideration via the secret and seriatim ballot on December 10, 2018 were given
the opportunity to interview before the Board. Mr. Carrillo was interviewed, without prior notice
that he would possibly be interviewed, for approximately nine minutes on December 18, 2018.

44. Following the conclusion of the interviews, Supervisor Lovingood again moved
to appoint Dawn Rowe. The motion was seconded and adopted. After a short recess, Rowe was
sworn in as Supervisor of the Board for the Third District.

PETITION FOR WRIT OF MANDATE

(Ralph M. Brown Act, Gov. Code § 54950 et seq.)

45. Government Code §54952.2(a) provides, in relevant part: "As used in this
chapter, 'meeting' means any congregation of a majority of the members of a legislative body at
the same time and location...to hear, discuss, deliberate, or take action on any item that is within
the subject matter jurisdiction of the legislative body."

46. Government Code §54952.2(b)(1) provides: "A majority of the members of a
27 legislative body shall not, outside a meeting authorized by this chapter, use a series of

communications of any kind, directly or through intermediaries, to discuss, deliberate, or take
 action on any item of business that is within the subject matter jurisdiction of the legislative
 body."

4 47. Government Code §54953(a) provides in pertinent part: "All meetings of the
5 legislative body of a local agency shall be open and public, and all persons shall be permitted to
6 attend any meeting of the legislative body of a local agency."

48. Government Code §54953(c) provides in pertinent part: "No legislative body shall
take action by secret ballot, whether preliminary or final. ... The legislative body of a local
agency shall publicly report any action taken and the vote or abstention on that action of each
member present for the action."

49. Petitioners are entitled to a judicial determination that the Ralph M. Brown Act
was applicable to Respondents' December 10, 2018 vote, and that this vote was a "series of
communications" within the meaning of Government Code §54952.2 by which the Board took
action on the selection of a Third District Supervisor and was conducted in violation of §54953.

15 50. Petitioners are also entitled to a judicial determination that the Ralph M. Brown
16 Act was applicable to Respondents' December 10, 2018 vote, that this vote was a secret ballot
17 within the meaning of Government Code §54953, and that the Board violated the Brown Act by
18 conducting a secret ballot to select a list of nominees to be interviewed and considered for the
19 position of Third District Supervisor.

20 51. Government Code §54960.1 provides, in pertinent part: "[A]ny interested person
21 may commence an action by mandamus or injunction for the purpose of obtaining a judicial
22 determination that an action taken by a legislative body of a local agency in violation of Section
23 54953... is null and void under this section."

24 52. Petitioners are entitled to a judicial determination that Respondents' electronic
25 mail vote on or about December 10, 2018 for a list of "nominees" to fill the vacant Third District
26 Supervisor position violated Government Code §§54952.2 and 54953; that on December 11,
27 2018 the Board interviewed only those candidates who were unlawfully so selected; that the

Board failed to cure or correct this violation because its consideration of candidates on December
 18, 2018 was informed by these unlawfully conducted interviews; and that the selection of Dawn
 Rowe as Supervisor on December 18, 2018 is therefore null and void under §54960.1.

4 53. Petitioners have no plain, speedy, or adequate remedy at law nor an administrative
5 remedy they may exhaust with regard to the deprivation of their statutory rights by the conduct
6 described herein.

7 54. Government Code §54960.5 provides in pertinent part: "A court may award court
8 costs and reasonable attorney fees to the plaintiff in an action brought pursuant to [Government
9 Code] Section ... 54960.1, ... where it is found that a legislative body of the local agency has
10 violated [the Ralph M. Brown Act]."

PRAYER FOR RELIEF

12 WHEREFORE, Petitioners pray:

13 55. That this Court issue a judicial determination that the Ralph M. Brown Act was
14 applicable to the vote taken on or about December 10, 2018 by the San Bernardino County

This letter is to call your attention to serious violations of the Ralph M. Brown Act, to demand that you cure and correct those violations, and to explain the inadequacy of what appears to be the Board's plans to correct those violations.

The nature of these violations is as follows: On or about December 10, 2018, the majority of the San Bernardino County Board of Supervisors, using a series of communications, deliberated and took actions toward appointing a Third District Member of the Board, and conducted a secret ballot vote to select those individuals who would be interviewed for this position (which resulted in excluding those applicants who were not so selected), in violation of Government Code §§54952.2(b) and 54953(c). As a result of this secret, unlawful vote, 30 applicants were excluded from consideration and were not permitted to interview on December 11, 2018.

California's open meeting laws clearly prohibit the use of mail or electronic mail to cast ballots to make legislative decisions. Legislative bodies, such as the Board, must "act *at meetings*." *See* 85 Ops.Cal.Atty.Gen. 103. Email votes are prohibited regardless of whether the legislative body later makes members' votes available to the public. 00 Ops.Cal.Atty.Gen. 906. The publication of the "tally sheet"—which does not show which Member voted for which candidate, making the election a secret ballot—as part of the Agenda for the Board's Dccember 18 Meeting does not address or in any way cure this violation.

It appears that the Board is attempting to address the illegality of its earlier actions by reconsidering all 43 eligible candidates at its December 18 Regular Meeting. However, any appointment of a Third District Member that is not preceded by providing an equal opportunity for all candidates to interview with the Board will be insufficient to cure the Board's past unlawful actions. Where a legislative body has engaged in secret fact-finding—such as collectively interviewing candidates—re-taking a vote in a public meeting does not cure the Brown Act violation. See Page v. MiraCosta Cmty. Coll. Dist. 180 Cal.App.4th 471, 505 (2009). Because the selection of the 13 candidates to be interviewed on December 11 violated the Brown Act, any continuation of the process of filling the Third District vacancy that does not address the improperly selective interview process should be considered null and void.

In addition, where, as here, a board has engaged in information gathering and discussion about a decision in violation of the Ralph M. Brown Act, simply "reconsider[ing] and approv[ing]" the

unlawfully private decision does not cure this violation. *Id.* Public officials may not engage in a private fact-finding or decision-making process "which ought to be made in public and then conduct a mere 'ceremonial' hearing to satisfy the open meeting requirement." *Morrison v. Hous. Auth. of the City of Los Angeles Bd. of Comm'rs.*, 107 Cal.App.4th 860, 876 (2003).

Pursuant to Government Code §54960.1, I demand that the San Bernardino County Board of Supervisors cure and correct these illegally taken actions as follows: Declare null and void the secret, unlawful ballot taken on or about December 10, and determine a process for selecting a candidate for the vacant Third District seat that is not tainted by the Board's past, unlawful actions: namely, that you allow all 43 candidates to participate in interviews with the Board, at a meeting or meetings that are properly noticed in conformance with the Brown Act's requirements. Only that solution will permit members of the public the opportunity for informed comment, and cure the Brown Act violations.

As provided by Government Code §54960.1, you have 30 days from the receipt of this letter either to cure or correct the challenged actions or to inform me of your decision not to do so. If you fail to cure or correct as demanded, such inaction may leave me no recourse but to seek a judicial invalidation of the challenged action pursuant to §54960.1, in which case I would also ask the court to order you to pay my seek court costs and reasonable attorney fees in this matter, pursuant to Government Code §54960.5.

I also take this opportunity to remind the Board that any member who attends a meeting of a legislative body where action is taken in violation of the Brown Act, and intends to deprive the public of information to which the member knows the public is entitled, is guilty of a misdemeanor under Government Code §54949.

COUNTY AND CHIEF EXECUTIVE OFFICER GOALS AND OBJECTIVES Operate in a Fiscally-Responsible and Business-Like Manner.

FINANCIAL IMPACT

Approval of this item will not result in the use of additional Discretionary General Funding (Net County Cost).

BACKGROUND INFORMATION

Third District Supervisor James Ramos has resigned and taken the oath of office at the California State Assembly - 40th District, resulting in a vacancy in the Third District Supervisor's office. The San Bernardino County Charter (Charter), Article 1, Section 7, provides that a vacancy in the office of Supervisor will be filled by appointment by majority vote of the remaining members of the Board of Supervisors (Board) from amongst qualified electors of the Supervisorial District in which such vacancy exists. The Charter further provides that the vacancy be filled by the Board within 30 days of the vacancy or the Governor makes the appointment to fill the vacancy. The Charter is silent as to any process to fill the vacancy. For example, the Board could merely appoint a successor to the Third District Supervisor without extensive process.

On November 13, 2018, and on December 4, 2018, the Board approved and then modified an application and selection process designed to provide an opportunity for qualified electors of the

Third District to be considered for appointment (Items No. 1 and Item No. 81, respectively) within the time constraints of the Charter and the 2018 holiday schedule. On December 4, 2018, the Clerk of the Board reported that applications from 48 qualified electors had been received. A list of the names of these 48 qualified electors is attached as Attachment "A". Pursuant to the process, the applicants were asked to submit supplemental materials consisting of responses to questions and any additional supporting materials. A total of 43 of the applicants submitted information by the deadline on December 7, 2018. A list of the names of those applicants is attached as Attachment "B".

On December 11, 2018, following the modified process approved on December 4, 2018, the Board interviewed thirteen applicants, as identified on Attachment "C," and established a finalists list of five candidates to be considered for appointment to the vacancy of the Third Supervisorial District seat on the Board. On December 12 and December 13, 2018, the County received correspondence challenging the selection process for filling the vacancy and alleging procedural violations. Because of the limited time in which the Board of Supervisors may exercise its right to make an appointment to fill the Third District Supervisorial vacancy, a legal defense of the open and transparent process is not practical. Contesting the allegations may result in a forfeiture to the Governor of the Board's right to make the selection. Accordingly, the recommended actions set forth above will mitigate any alleged procedural errors and afford the Board of Supervisors the opportunity at this meeting to deliberate and select a candidate to fill the vacancy of the Third District Member of the Board of Supervisors. The recommended amendment to the selection process is for the Board to determine that for purposes of its deliberations and selection, it will rely on the 43 applications submitted to the County, the supplemental questionnaires submitted by candidates, any other documentation submitted by a candidate, and the testimony and comments presented by members of the public in open session of the Board of Supervisors meeting on December 11, 2018.

CHARTER

of the County of San Bernardino, California

As amended by Charter Amendments Adopted through November 6, 2012

Charter

SECTION 7. A supervisor may be removed from office in the manner provided by law. Any vacancy in the office of supervisor will be filled by appointment by majority vote of the remaining members of the Board from amongst the qualified electors of the supervisorial district in which such vacancy exists. The appointee shall hold office until the election and qualification of his successor. An election shall be held to fill the vacancy for the unexpired term at the next general election unless the term expires on the first Monday of December next succeeding the election. Nomination and election of a supervisor for the unexpired term shall be by district in like manner as hereinbefore provided for such officer. In the event the Board of Supervisors shall not appoint to fill a vacancy within a 30-day period, such appointment shall be made by the Governor.

SECTION 8. BACKGROUND INFORMATION

The Board of Supervisors (Board) has been informed that on December 3, 2018, James Ramos took the oath of office as a member of the California State Assembly - 40th District resulting in a vacancy in the Third District Supervisor's office. Pursuant to the San Bernardino County Charter (Charter), a vacancy in the office of Supervisor shall be filled by appointment by majority vote of the remaining members of the Board from amongst qualified electors of the Supervisorial District in which such vacancy exists. In addition, the Charter, Article 1, Section 7, provides that: "In the event the Board of Supervisors shall not appoint to fill a vacancy within a 30-day period, such appointment shall be made by the Governor." The Charter is silent as to any process to fill the vacancy. For example, the Board could merely appoint a successor to the Third District Supervisor without extensive process.

Considering that the vacancy in the Third Supervisorial District occurred as of December 3, 2018, the Board must act to fill that vacancy on or before January 2, 2019. Taking into account the upcoming holidays, including days that the County is officially closed for business, the timeline within which to fill the vacancy is actually less than 30 calendar days and is extremely tight. The Charter does not establish or provide guidance on a selection process, but the Board's actions

are restricted by open meeting law requirements of the Brown Act. On November 13, 2018 (Item No. 1), the Board established a procedure for the filling of the anticipated Third District vacancy based upon the process used by previous Boards to fill prior Board vacancies. The prior uses of such a process by prior Boards was not subject to the same time pressures of the just-completed election cycle and the upcoming 2018 holiday schedule. The approved process includes an application period followed by interviews of applicants prior to making a selection.

Should the Board fail to name a successor prior to the January 2, 2019 deadline, the Governor would be required under the Charter and state law to make the selection. However, there is no statutory deadline within which the Governor must appoint to fill a vacancy. Without a firm deadline, it is likely that a long delay could occur resulting in the County operating with only four Board members for a significant period of time. This could affect County decision-making and business. Based upon the number of applications received and the extremely short timeline to make a selection in order to avoid invoking the Charter provision that would hand the process to the Governor, the Board may wish to reconsider, and modify, the selection process at this time.



Third District Supervisor James Ramos has resigned and taken the oath of office at the California State Assembly - 40th District, resulting in a vacancy in the Third District Supervisor's office. The San Bernardino County Charter (Charter), Article 1, Section 7, provides that a vacancy in the office of Supervisor will be filled by appointment by majority vote of the remaining members of the Board of Supervisors (Board) from amongst qualified electors of the Supervisorial District in which such vacancy exists.

On November 13, 2018, and on December 4, 2018, the Board approved and then modified an application and selection process designed to provide an opportunity for qualified electors of the Third District to be considered for appointment (Items No. 1 and Item No. 81, respectively) within the time constraints of the Charter and the 2018 holiday schedule. On December 4, 2018, the Clerk of the Board reported that applications from 48 qualified electors had been received. A list of the names of these 48 qualified electors is attached as "Attachment A".

Following the modified process approved on December 4, 2018, the applicants to be interviewed by the Board on December 11, 2018, and possibly at a special meeting on December 13, 2018, will be determined on Monday, December 10, 2018. <u>The modified process also requires the eligible applicants to submit a Supplemental Questionnaire to the Clerk of the Board by noon on Friday, December 7, 2018.</u> The Board will conduct interviews and deliberations and select the Third District Supervisor.

On Friday, December 7, 2018, 43 applicants submitted the required Supplemental Questionnaire by the noon deadline. In accordance with the modified process, nominations were made, which resulted in 13 nominees to be interviewed starting on December 11, 2018. A list of the names of these 13 nominees is attached as "Attachment B".

RE: Complaint of Violation of the Ralph M. Brown Act by the San Bernardino County Board of Supervisors (Individually and collectively), Robert A. Lovingood, Janice Rutherford, Curt Hagman, Josie Gonzales; Demand for Civil Remedies.

To the San Bernardino County Board of Supervisors, Robert A. Lovingood, Janice Rutherford, Curt Hagman, Josie Gonzales:

The San Bernardino County Board of Supervisors is subject to the Ralph M. Brown act codified in Gov. Code, § 54950 et seq.

On December 10 - 11, 2018, you the members of the County Board of Supervisors in concert and individually violated the Ralph M. Brown Act specifically CA Gov. Code, § 54953.5 when you did cast preliminary votes secretly, without a process agreed upon by the public and without publicly disclosing the votes of the individual supervisors to the public. The language of the law is very clear: *"All votes, except for those cast in permissible closed session, must be cast in public. No secret ballots, whether preliminary or final, are permitted."* On December 11, 2018, during public comment period of the item on the agenda, I cited the Brown Act in objecting to your elimination process and illegal polling of the members of the Board of Supervisors (secret ballots outside of a noticed meeting) constituting a prohibited meeting.

The fact of the prohibited voting by secret ballot is shown in Exhibit A (attached hereto and incorporated by reference) a copy of the "San Bernardino County Wire" published December 10, 2018, titled "Board narrows Third District appointment field to 13 Interviews tomorrow" The article states "*Members of the Board of Supervisors today selected 13 applicants as finalists for possible appointment to the Third District seat on the board. The following 13 people were invited to be available for public interviews during a special Board of Supervisors meeting for at 9 a.m. tomorrow after receiving support for advancement from two or more board members:*" [names of applicants receiving two or more votes from each board *member*]..."The county began the appointment process on Nov. 16 in anticipation of Supervisor *Ramos' departure by inviting qualified third District residents to apply for the appointment, 48 of whom responded*. <u>Board members submitted their top selections to the Clerk of the</u> <u>Board of supervisors this morning, and 13 received support from two or more board</u> <u>members, qualifying them as finalists."</u> (emphasis added to show the pertinent evidence of illegal secret ballots and voting). In casting votes outside of a public, properly noticed meeting, you, the named members of the San Bernardino County Board of Supervisors did deprive the public of information which you knew or had reason to know the public was entitled to receive, namely: 1) the vote count on the December 10, 2018 preliminary vote including who voted for whom; 2) the speech of the applicants who were not allowed to participate due to an unnoticed or wrongly noticed vote on December 10, 2018, intending to eliminate applicants in secret outside of the public forum.

The Brown Act punishes attendance by a member of a body at a meeting where action is taken in violation of the Act, and where the member intends to deprive the public of information to which the member knows or has reason to know the public is entitled (§ 54959). The purpose of the serial meeting prohibition is not to prevent citizens from communicating with their elected representatives, but rather to prevent public bodies from circumventing the requirement for open and public deliberation of issues.

The preliminary vote and the vote count was taken secretly on December 10, 2018, in what constitutes an illegal "serial meeting." Without the serial meeting, without the preliminary voting in secret on December 10, 2018, the Board members would <u>not</u> have been able to reduce the applicants to thirteen outside of the public forum. Illegally reducing the applicants outside of a public forum did something else of wrongful consequence. The consequence was that staff and the Supervisors knew had preliminary information as to how the other voting members would vote the next day, thus influencing their vote.

On December 11, 2018, while the "short-list" of candidates were being interviewed, a staff member privately reported to the press the names of several candidates who had received a unanimous four votes on the prior day. The information concerning the vote count was not made public. (See Declaration of Ruth Musser-Lopez on December 11, 2018).

The fix was in, the public was left out of the selection process, some applicants were not invited to address the Board and were not allowed equal time, and due to the illegal polling, Board members knew which applicants were "winning" prior to their vote. The consequence of a Board member knowing in advance which applicants were preferred by the other members had the potential of wrongfully influencing their vote without public knowledge or intervention.

The Act specifically prohibits any use of direct communication, personal intermediaries or technological devices that is employed by a majority of the members of the legislative body to develop a collective concurrence as to action to be taken. (§ 54952.2(b).)

On December 10, the public was denied the right to address the Board of Supervisors prior to votes being case; they were also denied the right to comment concerning the method or process of eliminating some applicants. The public was not allowed to comment prior to secret ballots being cast by the members of the Board to the Clerk of the Board of Supervisors which voting constitutes an illegal serial meeting. While the public was allowed a short (less than 3 minutes) opportunity for comment on December 11, 2018 at a noticed meeting, after a vote was taken reducing the thirteen unlawful candidates to five candidates, the public was notified that a "continued" meeting would be held at which the public would <u>not</u> be able to comment. The Brown Act states that matters properly placed on the agenda for the original meeting may be considered at the subsequent meeting (§ 54954.2(b)(3), however the matter was not properly placed on the agenda for the December 11, 2018 meeting because of 1) the illegal secret ballots eliminating some legitimate applicants, and 2) because the public was never provided an opportunity to support or oppose the legitimate applicants who were eliminated.

Further, the item being placed on the agenda for a special meeting on December 13, 2018, is a new item, not previously considered. In California, we have a primary and general. We don't deny the people the right to comment on the candidates in the general election just because they had a voice in the primary election. The same situation applies here. You have a new slate of candidates constituting a new agenda item. The public should have a voice in who gets to be elected out of that slate. Please pay attention to the regulations and case law:

As per Chapter IV. Section 2. "Special Meetings" (Lockyer 2003):

"Under the Act, the presiding officer or a majority of the body may call a special meeting. So long as substantive consideration of agenda items does not occur, a majority may meet without providing notice to the public in order to call the meeting and prepare the agenda. (216 Sutter Bay Associates v. County of Sutter (1997) 58 Cal.App.4th 860, 881-882.) Notice of a special meeting must be provided 24 hours in advance of the meeting to all of the legislative body members and to all media outlets who have requested notification. (§ 54956; 53 Ops.Cal.Atty.Gen. 245, 246 (1970).) The notice also must be posted at least 24 hours prior to the meeting in a location freely accessible to the public. The notice should indicate that the meeting is being called as a special meeting, and shall state the time, place, and business to be transacted at the meeting. No other business shall be considered at the special meeting. Notice is required even if the meeting is conducted in closed session, and, even if no action is taken. A member of the local body may waive failure to receive notice of the meeting by filing a written waiver prior to the meeting or by being present at the meeting.

"At every special meeting, the legislative body shall provide the public with an opportunity to address the body on any item described in the notice before or during consideration of that item. (§ 54954.3(a).) The special meeting notice shall describe the public's rights to so comment. (§ 54954.3(a).)"

In Stockton Newspapers, Inc. v. Redevelopment Agency (1985) 171 Cal.App.3d 95, 105, the court concluded that a series of individual telephone calls between the agency attorney and the members of the body constituted a meeting. In that case, the attorney individually polled the members of the body for their approval on a real estate transaction. The court concluded that even though the meeting was conducted in a serial fashion, it nevertheless was a meeting for the purposes of the Act. (See also, 65 Ops.Cal.Atty.Gen. 63, 66 (1982); 63 Ops.Cal.Atty.Gen. 820, 828-829 (1980).)

At this time, I, Ruth Musser-Lopez am a resident of San Bernardino County and am demanding relief, that you collectively as the Board of Supervisors void the action you have taken in violation of the act, namely: 1) void the December 11, 2018 vote on a replacement for the 3rd District Supervisor position; 2) void any other serial votes by members of the Board of Supervisors on December 10 and 11, 2018 and that to be voted on December 13, 2018 pertaining to the selection of a replacement Supervisor for the 3rd District; 3) in the future provide the opportunity for public comment every time a new slate of candidates is proposed. This demand is made as per Ch. VII 54960; 54960.1 "Individuals or the district attorney may file civil lawsuits for injunctive, mandatory or declaratory relief, or to void action taken in violation of the Act."

My further claim for relief is that the Board of Supervisors provide an opportunity for all applicants be invited to give a speech and allowed the same amount of time provided the unlawful slate of 13 candidates that were improperly selected by serial voting and secret ballots on December 10, 2018.



This is a violation of our constitutional rights to fair treatment and equal representation, is harassing and damaging, among other really sad discriminatory acts.

FINANCIAL IMPACT

Approval of this item will not result in the use of additional Discretionary General Funding (Net County Cost).

BACKGROUND INFORMATION

Third District Supervisor James Ramos has resigned and taken the oath of office at the California State Assembly - 40th District, resulting in a vacancy in the Third District Supervisor's office. The San Bernardino County Charter (Charter), Article 1, Section 7, provides that a vacancy in the office of Supervisor will be filled by appointment by majority vote of the remaining members of the Board of Supervisors (Board) from amongst qualified electors of the Supervisorial District in which such vacancy exists. The Charter further provides that the vacancy be filled by the Board within 30 days of the vacancy or the Governor makes the appointment to fill the vacancy. The Charter is silent as to any process to fill the vacancy. For example, the Board could merely appoint a successor to the Third District Supervisor without extensive process.

On November 13, 2018, and on December 4, 2018, the Board approved and then modified an application and selection process designed to provide an opportunity for qualified electors of the

Third District to be considered for appointment (Items No. 1 and Item No. 81, respectively) within the time constraints of the Charter and the 2018 holiday schedule. On December 4, 2018, the Clerk of the Board reported that applications from 48 qualified electors had been received. A list of the names of these 48 qualified electors is attached as Attachment "A". Pursuant to the process, the applicants were asked to submit supplemental materials consisting of responses to questions and any additional supporting materials. A total of 43 of the applicants submitted information by the deadline on December 7, 2018. A list of the names of those applicants is attached as Attachment "B".

On December 11, 2018, following the modified process approved on December 4, 2018, the Board interviewed thirteen applicants, as identified on Attachment "C," and established a finalists list of five candidates to be considered for appointment to the vacancy of the Third Supervisorial District seat on the Board. On December 12 and December 13, 2018, the County received correspondence challenging the selection process for filling the vacancy and alleging procedural violations. Because of the limited time in which the Board of Supervisors may exercise its right to make an appointment to fill the Third District Supervisorial vacancy, a legal defense of the open and transparent process is not practical. Contesting the allegations may result in a forfeiture to the Governor of the Board's right to make the selection. Accordingly, the recommended actions set forth above will mitigate any alleged procedural errors and afford the Board of Supervisors the opportunity at this meeting to deliberate and select a candidate to fill the vacancy of the Third District Member of the Board of Supervisors. The recommended amendment to the selection process is for the Board to determine that for purposes of its deliberations and selection, it will rely on the 43 applications submitted to the County, the supplemental questionnaires submitted by candidates, any other documentation submitted by a candidate, and the testimony and comments presented by members of the public in open session of the Board of Supervisors meeting on December 11, 2018.
